PCM, PAM, JMG Inc., JMG LLC, Mr. Glaser, Mr. David and Mr. Richter are filing this Form 4 jointly as a group within the meaning of Rule 13d-5(b) under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), but disclaim membership in a group with any other person. The Fund is filing this Form 4 jointly with the other Reporting Persons, but not as a member of a group, and it expressly disclaims membership in a group with any other person.
- 3. These securities are beneficially owned directly by Mr. Richter.
- 4. These are transactions in the Issuer's securities when its name was Citadel Holding Corporation.
- 5. These are transactions in the securities of Craig Corporation. Craig Corporation and Reading Entertainment, Inc. were consolidated with Citadel Holding Corporation on January 1, 2002 (the "Consolidation"). As part of the Consolidation, Craig Corporation and Reading Entertainment, Inc. became wholly owned subsidiaries of Citadel Holding Corporation and Citadel Holding Corporation changed its name to Reading International, Inc.
