Ms. Cotter is a trustee of the Trust and is one of three equal beneficiaries of the Trust and, as such, has a pecuniary interest in the shares shown.
- Price reflects the price paid for a 33% non-voting interest in Cotter Enterprises, LLC, and represents a discount from the value of the underlying securities reflecting the illiquid and non-controlling nature of the limited liability company membership interest involved. The price is subject to adjustment upward or downward based on a third party appraisal, which is currently in process.
