Registrant expects a significant change in results of operations from the fiscal quarter ended March 31, 1994, because Registrant was restructured on August 4, 1994 (the "Restructuring"). Pursuant to the Restructuring, Registrant divested itself of approximately 84% of Fidelity Federal Bank, a Federal Savings Bank. Registrant expects the Restructuring will significantly impact its results of operations.
